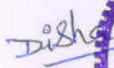

मेहता न पाठ स कहा-प्राक्रया शुरू हा गई ह आर राष्ट्रपति इसे पर फैसला लेंगे। यह वह मामला है, जिसमें दोषी पर खालिस्तान के मुद्दे पर पूर्व मुख्यमंत्री की हत्या करने का आरोप है। उन्होंने कहा कि मौजूदा परिस्थितियों में केंद्र को छह हफ्ते का समय दिया जाए। पीठ ने मेहता का अनुरोध स्वीकार करते हुए मामले की सुनवाई छह हफ्ते के लिए स्थगित कर दी। शीर्ष अदालत ने 25 जनवरी को राजोआना की मौत की सजा बदलने के लिए दायर याचिका पर फैसला करने के लिए केंद्र को आखिरी मौका देते हुए दो हफ्ते का समय दिया था।

सुनवाई के दौरान राजोआना की ओर से वरिष्ठ वकील मुकुल रोहतगी ने कहा था-यह आदमी (राजोआना) पिछले 25 साल से जेल में कैद है और उसकी दया याचिका पिछले नौ साल से लंबित है। मालूम है कि राजोआना पंजाब पुलिस का पूर्व कांस्टेबल है और उसे 1995 में पंजाब सचिवालय के समक्ष हुए धमाके में शामिल होने का दोषी ठहराया गया था। जिसमें बेअंत सिंह और अन्य 16 लोगों की मौत हो गई थी।
